**RELEASE AND INDEMNITY**

In consideration of the right to enter lands owned or leased by the Landowner in Harris, Waller, or Fort Bend Counties, Texas, I release, acquit and forever discharge the Landowner from any and all claims or causes of action of any kind whatsoever, at common law, statutory or otherwise, that may arise from my use and entry upon such lands. This Release shall include any accident, incident or occurrence proximately caused by the negligence of the Landowner.

I further agree that I, my heirs, successors and assigns, will not make any claim or institute any suit or action at law or equity against the Landowner arising from any such accident, incident or occurrence.

I further agree to protect, indemnify and hold harmless the Landowner for any loss by them arising from any acts by me, whether negligent or not, while I am upon or using any lands owned or leased by the KATY PRAIRIE CONSERVANCY or THE WARREN RANCH.

**I UNDERSTAND THAT BY SIGNING THIS RELEASE AND INDEMNITY, THAT I HAVE AGREED NOT TO BRING SUIT OR ASSERT ANY CLAIM AGAINST THE LANDOWNER EVEN THOUGH I OR MY PROPERTY ARE INJURED OR DAMAGED AS A RESULT OF THE NEGLIGENCE OF THE LANDOWNER, THEIR RESPECTIVE GUESTS OR ANY OF THE ABOVE DESCRIBED PARTIES WHILE I AM UPON OR USING THE OWNED OR RENTED LANDS OF THE LANDOWNER. I ALSO UNDERSTAND THAT I HAVE AGREED TO INDEMNIFY, PROTECT AND HOLD HARMLESS THE LANDOWNER FOR ANY ACTS BY ME WHICH CAUSE DAMAGE OR INJURY WHILE I AM ON LANDS OF THE LANDOWNER.**

The term "Landowner" includes all agents, employees, board of directors, advisory board members, assigns, and agricultural tenants of the Katy Prairie Conservancy and all co-owners, agents, employees, assigns and agricultural tenants of the Warren Ranch.
